- III. Michael Broyles (6th child of Jacob Broyles and Mary Catharine Fleishman) was born June 1740, according to his statement in his application for pension made 8, Nov. 1833. His name appears in 1836 on a list of those receiving pension for services inthe Revolution from Jonesboro, Washington Co., Tenn. From a record given below he was still living in 1839 or the first part of 1840. This agrees with tradition in his family. He almost or quite reached the century mark. He was the last to surviv of the children of Jacob Broyles, with the possible exception of some of his daughters. Michael Broyles married probably about 1764 to Elizabeth Klug, daughter of the Rev. George Samuel Klug. He received by the terms of his father's will "one hundred acres of land, a Beast, a Cow and Calf and a Bed and a pot and pan". On 16, June 1776 Michael Broyles and wife elizabeth sold to John Deer, Jr., 116 acres. He entered 400 acres in 1780 on the Licking in Jefferson Co., Ky., which claim is not heard of later. He and his wife appear in the communion rolls of Hebron Church in 1775-77. Only one of his children appears in the Birth Register, namely, Michael Breil, born 19, Jan. 1777, baptized 13, Apr. 1777 with Conrad Wilheit and wife, Moses Breil and Elizabeth Breilin as sponsors. The following record is found in Madison C. H., Va: On 10, June 1801, Michael Broyles and wife Elizabeth, Matthias Broyles and wife Eve, now all of Greene Co., Tenn., said Elizabeth and Eve Klug (sic) being heirs of Susanna Medley formerly Susanna Klug, new dec'd, appoint William Lotspeck of Stafford Co., Va. as attorney. Signed by Michael Broyles. his mark, Matthias Broyles, his mark, and witnessed by Thomas Prather and William Prather, his mark. Susanna Medley was the mother of Elizabeth Klug Broyles and Eve Klug Broyles, and the formerly the wife of the Rev. George Samuel Klug. She seems to have outlived her first husband by many years, Aside from the two daughters who married Broyleses they had a daughter who married Godfrey Yager and another daughter who married William Lotspeck, probably the William Lotspeeck of the above record. The Rev. George Samuel Klug is said to have had but one son, who seems to have died without issue. The name Klug is not found in later Madison County records. His only descendants come from the four daughters mentioned above.

The Will of Jacob Broyles (2) November 3rd 1761.

I, Jacob Broil, of the Parish of Bromfield in Culpeper County being sick and week in body, but of a sound and perfect mind and memory, thanks be to God for the same. But calling unto Mind the Mortality of my Body Knowing that it is appointed for all men to Die I therefore do make and Ordain this my last Will and Testament that it is to say, Principally and first of all I give and Recommend my Soul into the hands of almighty God that gave it, Trusting and surely believing that that Through the Merits of my Blessed Saviour I shall receive full forgiveness and Remission of all my Sins, and My Body I recommend to the Earth to be buried in decent Christian Burial, Nothing doubting but that at the General Resurrection Ishall receive the same by the mightly Power of God and as touching such wordly Estate as it please God to Bless me with in this life, I do Demise and dispose of the same in the following form and Manner:——

Firstly, I give and Bequeath unto my Beloved wife Catharine Brail the use of my houses and Plantation whereon I now do live during the term of her Natural Life and after my Beloved Wife's Decease my beloved Son Matthias is to have the said my Houses and Plantation land to him and his heirs forever, and if in case the said Son Matthias Broil should Die without an heir then the Next youngest Son is to have it for him and his heirs forever and if in case the next young-

est son is to have for him and his heirs forever.

Secondly I give and bequeath unto my beloved Son Peter Broil one hundred acres of Land a Beast a Cow and Calf and Bed and a Pot and a Pan the said Hundred Acres of Land to be taken off of a Tract of four hundred Acres of Land which I Possess in my own Right and title to be taken off with a cross line to him and his heirs forever.

Thirdly I give and bequeath to my beloved Son Michael Broil one hundred acres of land, a Beast, a Cow and a Bed and a pot and Pan the said hundred Acres of land to be taken off of the before mentioned tract of four hundred Acres of land to be taken off with a Cross

line to him and his heirs forever.

Fourthly I give and bequeath unto my Beloved Son John Broil one Hundred Acres of land, a Beast, a Cow and Calf and a Bed and a pot the said one hundred Acres of Land to be taken off of the before mentioned Tract of four hundred Acres of Land with a Cross line for him and his heirs forever.

Fifthly I give Bequeath unto my Beloved Son Zachrias Broil one Hundred Acres of Land a Beast a Cow and a Calf, a Bed and a pot and pan the said one hundred acres of Land to be taken off of the Beforementioned Tract of four hundred Acres of Land with a Cross line to

him and his heirs forever.

Sixthly I give and bequeath to my Beloved Daughter Mary Broil a Cow and Calf and a Bed and Pot and pan and son Pewter to her and

her heirs forever.

Seventhly it is my will and Desire that all the Rest of my Personal estate all the above mentioned have their promised shares, shall be Equally Divided amongst my sons and Daughters that is to say my Son Adam Broil and my Son Nicholas Broil and my son Michael Broil my son Jacob Broil and my son Peter Broil and my son Cyrus Broil and my son John Broil and my son Zacharias Broil, and my son Matthias Broil and my beloved Daughter Catharine Wayland and my beloved daughter Elizabeth Wilhite and my beloved Daughter Mary Broil to them and their heirs forever.

Eightly and Lastly I make and Ordain my Beloved Sons Adam Broil and Nicholas Broil Executors of this my last Will and Testament. Revoking all other wills by me made and in Witness that this to be my Last Will and Testament I have hereunto put my hand and Seal this third day of November in the year of our Lord one thousand and siven

hundred and Sixtyone.

First my will and Desire is that my son Frederick Brile is to Have the Plantation of One hundred acres of Land and he is to maintain his father and mother During their lives and he is to have the Thirds of the Estate and the rest of my Estate is to be equally Divided amongest the Heirs as follows Namely Adam Briles Crafford Rush peter Summa Fedrick Whaymoir Jonas Hewver George Brile thomas scrivner Also to my son Adam I give one hundred acres of land the Uper part of the Land he paying Twenty one pounds to the Executors Also my two grand Daughters Mary and Margaret is to have and Injoy one Equal part with the Rest of the afforsaid Heirs by them Freely to be possessed and Injoyed Benjamin rush Thomas Scrivner I likewise constitute make and ordain my sole Executors of this my Last will and testement This and no other to be my last will and testament in witness Whereof I have Set my hand and Seal This day and year above written.

Russell, of Virginia Militia ---Lt. Yancey--marched to Fort Pleasant against the Shawnee Indians- he states further he contined at sd. Fort from 1st May until 1st Janfollowing and then he was discharged. He was again called upon to perform a tour of three mos. at time the prisoners were conveyed to Albemarle, after the surrender to Washington again a tour in Jan. 1777 -again in the fall of 1778 a tour of duty hired a man by name of Hawkins for which he gave him a horse and the sd. fall he removed from Virginia to western part of N. C., noe Tennessee and settled on border of the Cherokee Indians- a fort or station was kept at his home on Nolichuckey, where he guarded the frontier, etc.-sd. service under Col. Sevier, Samuel Mauk, and Brooks H. Bell are Witnessess, Etc. persons known to him, etc. Sworn to before Wm. Gilleyland, 8th Nov. 1833-
